INFO COVID-19

Dear colleagues,

I come back with new information regarding the situation of COVID-19 in Romania.

On August 1 the situation of COVID-19 in Romania is very good, the incidence rate is less than 0.06 per thousand inhabitants. 5 million Romanians were immunized, exceeding 25% of the population.

According to the current internal regulations of Romania, the members of the sports delegations arriving in Romania to participate in sports competitions organized on the national territory, from countries in the red zone of epidemiological risk are exempted from the quarantine measure established according to the provisions of this decision an RT-PCR test for SARS-CoV-2 infection performed no later than 72 hours before entering the country and participating only in activities within the mentioned competitions.

The Government of Romania issued Decision no.44 / 07.July.2021 regarding the extension of the state of alert by 30 days in Romania, starting with July 12.2021.

According to the Decision of the National Council for Emergency Situations, the imposed restrictions are maintained:

-the obligation to wear a mask in crowded spaces;

-conducting sports competitions on the Romanian territory, in open spaces, to be achieved with the participation of spectators up to 50% from the maximum capacity of the space. Participation is only allowed for people who are vaccinated against the SARS-CoV-2 virus for which they have 10 days after the completion of the complete vaccination schedule, people who shows the negative result of an RT-PCR test for SARS-CoV2 virus infection not older than 72 hours or the certified negative result of an antigen test rapidly for SARS-CoV-2 virus infection not older than 24 hours, respectively persons who are in the period between the 15th day and the 180th day thereafter confirmation of SARS-CoV-2 infection, under the conditions established by the common order of the Minister of Youth and Sport and the Minister of Health;

-allowing the development of sports competitions on the territory Romania with the participation of spectators over 50% of the maximum capacity of space can only be

achieved with the participation of people who are vaccinated against the SARS-CoV-2 virus for which 10 days have elapsed since completion the complete vaccination schedule, under the conditions established by the joint order of the Minister of Youth and Sports and the Minister of Health;

-organizing private events such as weddings, baptisms, festive meals, etc., not limited to them, in salons, cultural centers, restaurants, bars, cafes, event halls / tents, with a maximum number 150 people outside or up to 100 people inside counties / localities where the cumulative incidence at 14 days is less than or equal to 3 / 1,000 inhabitants. When determining the number of people outside and / or inside are not taken people under the

age of 16. Events can be organized and with the participation of people up to the maximum capacity of the space, if all participants are persons vaccinated against the SARS-CoV-2 virus for which 10 days have elapsed since the completion of the complete vaccine schedule;

- the activity of restaurants and cafes inside hotels, boarding houses or other accommodation units, as well as on their terraces, can be carried out up to the maximum capacity of the space and only in the time interval 05.00-02.00, in the counties / localities where the cumulative incidence of cases is 14 days less than or equal to 3 / 1,000 inhabitants and only for persons accommodated in within these units;
- exemption from the obligation to wear a mask protection at workplaces in enclosed spaces where they carry out their maximum activity 10 persons, provided that they have been vaccinated against the SARS-CoV2 virus and for which 10 days have elapsed since the completion of the complete vaccination schedule, and with ensuring a distance of 1 meter between them, and in those areas is not allowed access to the public or other workers, remaining mandatory in all spaces closed common.

I will inform you periodically about the evolution of the COVID-19 situation in Romania.
